GROUP BOOKING CONDITIONS

1. The **charges** agreed are based on the inflation rate at the time of printing. Live the Adventure Ltd reserve the right to increase prices. Any increases in charges will be notified in writing to those with provisional or confirmed bookings. Confirmed bookings within three months of arrival date will not be subject to any such increases.
2. **Provisional bookings** which the Live the Adventure Ltd Centre has accepted by telephone or in writing will be held for fourteen (14) days only from the date of acceptance.
3. A **booking** is only deemed as confirmed when the Centre has received a completed booking form accompanied by a non returnable **deposit of 25%** of the full cost. **Deposits are non-refundable.**
4. **Final payment should be sent to the Centre 4 weeks prior to the course or activity**
5. **Cancellations / Reductions in numbers**
 - a) Final number must be confirmed within 2 weeks prior to arrival.
 - b) Cancellation of the entire booking made within 90 days of the start of the stay will be charged 25% of the full fee.
 - c) Cancellation of the entire booking made within 60 Days of the start of the stay will be charged 50% of the original fee.
 - d) Cancellation of the entire booking made within 30 days of the start of the stay will be charged the FULL FEE .
6. All activities are subject to change and availability. No refunds can be made in respect of accommodation vacated before the departure date, meals not taken or activities booked but not used.
7. **Liability**
 - a) Live the Adventure Ltd are covered for Public Liability and Employers Liability. Groups requiring additional cover are advised to contact their own insurance company.
 - b) Live the Adventure Ltd and its staff can not accept liability for damage to, or loss of, personal property. Groups are advised not to bring personal items of value with them.
8. **Smoking / Drinking** Smoking is not permitted in any building and the consumption of alcohol or any other narcotic is not allowed on-site.
9. **Discipline** Group leaders are responsible for ensuring high standards of conduct within their groups. A high standard of conduct behaviour is expected during the stay or time on site. Live the Adventure Ltd reserves the right to dismiss guests who persistently ignore the rules or act in a manner likely to affect the safety, comfort or well-being of other guests or staff. In such circumstances no refunds will be given.
10. **Damage** A group is responsible for the cost of any damage to the Centre's equipment and / or property caused by misuse.
11. Live the Adventure Ltd reserves the right to cancel a booking for whatever reason. In such a situation all monies paid to the Centre will be refunded in full.
12. Live the Adventure Ltd reserves the right to terminate any booking by groups failing to meet these booking conditions.
